



STUDENT DRIVER AGREEMENT

During the senior years of schooling many of our students become drivers and often start driving themselves to school. Whilst this is a significant and exciting rite of passage for our young people it is critical that we know who they are and the vehicles they are driving, to ensure safety for all students.

Please be aware that a Provisional Driver is not permitted to transport other students in their car unless they are siblings. This policy has been put in place to safeguard the well-being of all students and minimize potential liability for both parents/carers and students in the event of a serious incident.

Additionally, we would like to emphasise that students are not allowed to leave the school grounds during the day to retrieve items from their vehicles without explicit written consent from a Deputy Principal. In cases where an item is needed urgently, a Deputy Principal may grant a written leave pass or contact the parent/carer for further authorization.

The conduct of our students while driving reflects upon our entire school community. We appreciate your cooperation in adhering to the following conditions for driving to and from school:

CONDITIONS FOR DRIVING TO/FROM SCHOOL

- Student drivers are not permitted to carry passengers other than siblings
- Parking on school grounds is not permitted
- Leaving the school grounds during school hours requires explicit written permission from a Deputy Principal
- Driving to school sport, excursions, or activities is only permitted with prior authorisation from parent/carer and the school activity coordinator must have completed the risk assessment prior to approval by the principal.
- The completed student driver agreement should be submitted to the office and approved by the Year Level Deputy Principal before commencing driving to and from school
- A copy of the student driver agreement must be kept in the student driver's vehicle and presented upon request
- Any changes to driver, vehicle, or passengers require a new permit application
- The permit is valid for 12 months from the approval date, with the option to reapply as needed
- Loss of the permit should be reported immediately for a replacement
- It is important to note that the school will inform parent/carers if we are made aware of any reports to the Queensland Police Service regarding unlawful or unsafe driving by a student.

We appreciate your ongoing commitment to the safety and well-being of all our students. Thank you for your cooperation and support in reinforcing these expectations.
